# ODPC Machakos Regional Office Engages Civil Society Organizations on Data Protection Compliance

## **ODPC Showcases Data Protection at Nairobi International Trade Fair 2025**



As part of its ongoing drive to promote awareness and compliance under the Data Protection Act, the Office of the Data Protection Commissioner (ODPC) participated in the 2025 Nairobi International Trade Fair held at Jamhuri Park from 29 September to 5 October 2025 under the theme "Promoting Climate-Smart Agriculture and Trade Initiatives for Sustainable Economic Growth."

At its exhibition stand, the ODPC engaged fairgoers—business leaders, innovators, farmers, government agencies, and private citizens in conversations about data privacy, regulatory requirements, and ethical data handling. Highlights of the ODPC's presence included:

Registration Drive: The ODPC used the opportunity to facilitate on-site registration for institutions required to register under the Data Protection Act. Visitors were guided through the registration process, clarifying roles of data controllers and processors.

Awareness Materials: Brochures, infographics, and posters were handed out, illustrating rights of data subjects, obligations of data handlers, and frequently asked questions.

Dialogue and Stakeholder Engagement: ODPC staff held minisessions and Q&As at the stand, allowing attendees to ask about enforcement, dispute resolution, and how data protection links to trust in digital services.
